Summary of Decisions of the Washington Bird Records Committee

These files provide summary information on all the reports voted on by the Washington Bird Records Committee (WBRC). We have divided the reports into groups depending on the outcome of the votes: 'Accepted' and 'Not Accepted', 'Tabled' (consideration has begun, but a final decision has not yet been made), and 'Historical, Unreviewable' (early reports that have insufficient evidence to be properly reviewed). The files are presented as pdf files for cleaner printing, and as an excel sheet for anyone interested in sorting or customizing the information.

In all cases, the details provided in the formal published reports of the WBRC (#s 1-14), in *Washington Birds* and *Western Birds*, are more authoritative than this summary. In addition, more information can often be found in those published reports. Our hope is that this presentation will provide quick summary access to all the reports, much like an index. While we attempted to avoid any mistakes, inevitably we know that errors will sneak in to this Summary. We appreciate any corrections, suggestions, and questions and will rely on public input for help improving future versions of this Summary. Please email such responses to wbrc@wos.org.

A few formatting notes:

On the heading line for each species is a summary of the number of reports accepted and not accepted for this species. If the species is no longer on the review list, that information is also included in the heading line.

Report #s follow the convention of a 4-letter code, the year of the sighting, and a sequential number indicating when the report was received. ROGO-1992-2 would thus be the 2nd report received of a Ross's Goose seen in 1992. In some cases the same report # was assigned to two different reports in published accounts. In this spreadsheet these are distinguished with 'a' or 'b' at the end of the report #.

After the report number we list the location (usually city, then county), the date of the sighting, notes on the observation (number, plumage, and information on any earlier votes), and observers (i.e., those who submitted reports, not necessarily all who observed the bird). The final notes indicate where the published account of this decision can be found, usually in the form of a WBRC report # followed by a reference to journal issue # and page #. Thus '[WBRC#3 (WA Birds 6:21)]' would refer to the third WBRC Report, published in *Washington Birds* #6, on page 21. For those reports voted on but not yet published, we have indicated either the in-process WBRC Report where they will be included, or the WBRC meeting where the decision was made as a temporary substitute for publication details.
